Reopening Plan of HES For 2021-2022

Here is the reopening plan documents that we will be following that will guide all of us as we reopen our school to students on August 25, 2021.

You will notice that the documents are exactly the same plans we published in 2020 which we followed through-out the 2020-2021 academic year. These plans carried us through the entire year and we were able to meet our very difficult goal of:

Every Child, Every Day for 183 days

This reflects our successful year and only 3.1% of all Connecticut schools were able to accomplish this record of continuous educational programing.

We have made only minor changes to these plans based on the changes made by the CDC for schools. These changes are:

3' of social distancing not 6'
Whole cohorts may not need to quarantine
Outdoor classes are encouraged
Generally, masks are not required for outdoor recess

Since all of our students are not vaccinated, masks will be required of all people working in our building. All of the HES staff have reported that they are fully vaccinated. Our nightly sanitizing process will continue.

One major change has been the decision by the Hampton Board of Education to reduce the number of buses from three to two and this will directly impact the length of our daily rides to and from school. With that in mind, we will continue to offer morning drop off and afternoon pick-up service. We anticipate more parents will chose this option.

We will also continue to offer distance learning as an option for parents who remain concerned about their child attending HES. Once again, Mr. Gervase will provide remote lessons that your child's teacher will forward to him.

Finally, members of the certified teachers, the administration, and members of the Board of Education and the Reopening Discussion Group - who represent all stakeholders in Hampton - have reviewed the ESSER iii (Covid funding) Grant that was developed by Dr. Olah, Ms. Roberson and Mrs. Danielson.

The ESSER iii Grant can be found on the HES website. The major items being purchased will provide enhancement opportunities for students in after school programing as well as an enrichment summer experience for the summer of 2022. In addition, the Grant will purchase new playscape units and A/C for all TEAM classrooms.

We are looking forward to an exciting and safe new school year at HES. Our goal remains as it was last year:

Every Child, Every Day for 183 days

Health Room and Services Reopening Plan by Area

Fall 2020 8/17/2020

Guidelines based upon State of CT's Adapt, Advance, Achieve: Connecticut's Plan to Learn and Grow Together.

HES will comply with all directives to keep students and staff as safe as possible by following all guidelines put forth by the CDC, CT Dept. of Education, CT Dept. of Health, Northeast District Department of Health and Dr. Gorin, medical advisor. We will work closely with our partners to keep health and safety as a first priority in the 2020-2021 school year. Guidelines may change frequently as new information regarding COVID-19 becomes available from our partners.

Health Screening and Response

Daily self/parent screening for staff and students is required. Staying home when ill is a foundational aspect of staying as safe as possible at school. Absences may be increased this year as many COVID-19 symptoms overlap those of mild, common illnesses. **COVID-19 illness can include one or multiple symptoms.** Often children can experience mild symptoms, but still be positive for COVID-19. Update plans for sick child care so students may stay home when ill. Students/staff with allergies or asthma should have medications and wellness plans up to date to prevent overlap of COVID-19 symptoms. It would be a good idea to check in with primary care if updates to baseline is required. All immunizations must be up to date before returning to school.

The Northeast District Department of Health has suggested that screening daily even before school can help establish a regular routine as we prepare for the start of the school year.

Stay home from school if you can check off any of the following symptoms:

Symptoms of COVID-19 (* per Addendum 5 https://portal.ct.gov/-/media/SDE/COVID-19/Addendum-5-Interim-Guidance-for-
Responding-to-COVID-19-Scenarios-in-CT-School-Districts.pdf — most important identifying symptoms)

- Fever (100.0) or feeling feverish with chills *
 Cough *
 Shortness of breath or difficulty breathing *
 Fatigue
 Muscle or body aches
 Headache
 New loss of taste or smell *
 Congestion or runny nose
 Nausea or vomiting
 Diarrhea
- Contact with a person who has been diagnosed with COVID-19 *

If a student develops symptoms of illness at school, he/she will be referred to the school nurse and parents will be called for immediate pick up. Both emotional and physical well-being will be top of mind so as to encourage and support any student feeling ill at school. As in keeping with CT DPH and CT Department of Education guidance, PPE will be utilized by the school nurse while waiting with the student if symptoms of COVID-19 are assessed.

HES will work closely with NDDH and CT DPH to obtain guidance regarding confidential case reporting, illness monitoring, and possible closing of school should absences increase and/or possible COVID-19 cases arise.

Daily Health Practices

Health and safety of students and staff will be a priority for HES as put forth in the HES reopening plan. Staff, students, and parents will attend health teaching and review of all mitigation strategies as put forth by the State of CT's reopening plan. We want parents to have a full understanding of all strategies and protocols upon school entry.

- 3 days will be utilized before the opening of school for training purposes for staff
- Protocols and mitigation strategies will be communicated and reviewed at the start of school and on a continuing basis to reinforce safe strategies
- Communication to parents via email and website regarding updates and protocol will be utilized to allow parents the opportunity to learn about safety measures and ensure their children have an understanding of safety measures before the start of school.

Supplies

HES has ordered and will be securing the recommended safety supplies as put forth by the CT Dept. of Education. These supplies include:

- Masks
- Gloves
- Surgical gowns for use in isolation room and/or where necessary
- Face shields
- Some desk shields where necessary
- Alcohol based hand sanitizer and stations
- · Green cleaning supplies
- EPA registered disinfecting supplies

HES will update this health room plan should new guidance from state and local partners becomes available. New information is released frequently in this fluid situation. It is a difficult, but temporary time for our town, state, nation, and world. Health and safety will continue to be of the utmost importance as we work through this time together.

	All people wishing to speak with office staff at entrance window must wear face mask.

	Drivers must enter school lot at roadway entrance marked "HES Entrance" and then follow directions for stopping to let off students. Follow exit directions.
	During drop-off and pick-up, vehicles are to line up along right side of the roadway entrance and move forward when directed by school staff to drop-off or pick-up students.

	Bathroom breaks by cohort timing planned with other teams using the same bathrooms.
	Main office = only administrative office personnel and visitors.
	Faculty bathroom = Staff & Faculty only.
	Bathrooms in front central hallways = Teams A & B.
	Bathrooms at gym end of building = Art, Music, PE, Team C.
	Health room bathroom only by arrangement with Mrs. Danielson.
	Ventilation in all bathrooms on 24/7 and doors will remain open.
	Bathroom high touch areas - toilets, flush handles, door handles, sinks, faucets, - will be sanitized twice each day during school and each evening.
	Proper hand washing signs will be displayed in all bathrooms.
School Cleaning/ Sanitizing	
	All Pre-K bedding, and Team K toys will be sanitized via washing machine/dryer or dish washer each evening.
	Team K teachers will fill laundry style baskets for sanitizing before leaving school for the day.
	All student supplied fabric masks will be placed in mash style bags for washing at the end of each day (Masks will have student names).
	The school will be cleaned by a crew and then sanitized each evening by 10:00 pm in order to allow for sanitizing agents to kill the virus and dissipate before students enter the building at 8:30.

Health Room and Services	
	Daily screening by parents for illness is required - see Health Room Addendum attached.
	Parents must report all student absences to the Health Room and all symptoms and absences will be monitored.
	If your child is ill, call for instructions.
	Mrs. Danielson, RN, full time nurse at HES, is the sole person making medical decisions. She follows Dr. Gorin, MD (school physician) Center for Disease Control, CT State Department of Education, and Northeast District Department of Health guidelines.
	Mrs. Danielson will determine if student shall be placed into isolation room.
	The school nurse will notify a parent or guardian for immediate removal of any child placed in medical isolation. The nurse will wear PPE and remain with the child until the child leaves. A recommendation to contact child's health care provider will be made.
	Procedures for staff when concerned about Covid related behaviors is to contact the health room. When concerned about other student issues including discipline and/or social and emotional concerns is to contact the office.
	All staff will follow blood-borne pathogen, contagious illness, and COVID policies.
	All staff will follow all restraint and seclusion training responses to student behaviors.
	Students whose parents request a cloth face mask will receive two masks through the health room. One mask will be worn home each afternoon and the second mask will be washed at school. Disposable masks will be supplied for students who forget their masks.
	HES supplied cloth masks will be labeled with student names.
Food Services	
	During breakfast, snacks, and lunch, face masks will be removed and all student must remain 6' distant from each other. Once finished eating, the face masks will be worn.
	All students will receive a daily prepackaged breakfast and lunch and food allergy policies will be followed.
	All students will have a breakfast and a choice of two prepackaged lunches that will be distributed directly to their classrooms.
	All student will place all of their food waste into the food only garbage containers that will be filled and then placed into the hallway and removed by custodial services.
	All staff and faculty will have lunch in the library maintaining social distancing at all time.
	All staff and faculty will place their food trash into the food only waste cans and sanitize their lunch area.
	The faculty and staff room may only be accessed for bathroom use, to store their lunches, and prepare lunches using microwave and/or coffee maker while maintaining social distancing at all times.

	All teacher mail will be delivered twice daily to the mailboxes next to their classrooms.
Team schedules	
	Team schedules will be implemented by each Team Leader as presented in the official class schedule.
	Modifications are allowed during times marked, "Teacher Choice".
	Team Leaders will coordinate their times when the class will pass out of the classroom to various activities in order to have little to no cohort interactions.
	Team Leaders will contact the office when their class is moving outside for recess, class lessons, or mask removal rest periods (always following social distancing practice).
Common Touch Points	
	All bathrooms will be sanitized daily during the school day on a specific schedule.
	All xeroxing key pads will be sanitized after each use.
	All doors will be left open in order to reduce the number of common touch points.
	All common touch points will be identified and cleaned on a schedule as directed by Mrs. Danielson.
Face Masks	
	All students must wear face masks from the time they enter the bus until they exit from their bus at the end of each day except during breakfast, snack, lunch, outdoor physical education, or teacher directed face mask breaks.
	Any inability to wear a mask due to medical reasons must be discussed with the school nurse on a confidential and individual basis with a discussion of alternate methods of face coverings that may include face shields or a desk shield.
	Both cloth or medical masks that fully cover nose and mouth are required by the CSDE and the governor's proclamations.
	A cloth or medical mask will be provided for any student, staff or visitor who does not have a mask before entering the bus or school.

	All PE classes will be held outside weather permitting with no masks and social distancing and indoor with no physical activities that requires the removal of facial masks when held indoors - face masks will be used indoors.
	All equipment used by students will be sanitized between classes and at the end of each academic day.
Health	
	Health Classes will be brought to the classrooms with 1/2 the cohort in the classroom.
	Any materials and equipment used by students during the health class will be wiped and sanitized between classes and at the end of each academic day.
Art
